## TAX REFUND

#### WHAT IS TAX REFUND?

Tax refund is a reimbursement made to a taxpayer for any excess amount paid beyond their actual tax liability in a given period.

### WHO IS ENTITLED TO A TAX REFUND?

- ·All compliant taxpayers with excess tax payments
- ·Claims as a result of a decision of Tax Tribunal or Court of Appeal
- ·Taxpayers such as diplomats, diplomatic organizations and NGOs who are exempted from paying VAT
- ·VAT taxpayers engaged in zero rated supplies (exports)

# WHAT ARE THE CIRCUMSTANCES UNDER WHICH TAX IS REFUNDABLE?

- •When total income tax paid in a given period exceeds all outstanding tax liabilities.
- ·VAT is refundable when input tax is greater than output tax for three consecutive months.

·VAT is refundable to diplomats, diplomatic organizations and NGOs who are exempt from paying VAT. These must show proof of VAT paid and each individual invoice should exceed GMD 50.00.

## WHAT IS REQUIRED TO APPLY FOR A TAX REFUND THROUGH THE E-PLATFORM?

- ·Compliance with all tax obligations
- ·Access the GRA web portal https://www.gra.gm
- ·Login profile credentials
- ·Relevant supporting documents
- ·Bank details

### HOW DO YOU APPLY FOR TAX REFUND THROUGH THE E-PLATFORM?

- ·Access the GRA web portal https://www.gra.gm
- ·Login to web portal with profile credentials
- ·Complete refund claim application
- ·Attach relevant supporting documents
- ·Submit

On submission, the system notifies refund applicant acknowledging receipt of refund claim, with tracking number and URL to track refund application. If claim is approved, taxpayer is notified of approval of refund claim.

### WHAT ARE THE OFFENCES RELATED TO TAX REFUND CLAIMS?

- ·Giving false or misleading information
- •Forging of tax documents and/or information.
